## Perpetual WealthFocus Super Plan (ABN 41 772 007 500, RSE R1057010) - Perpetual Geared Australian Investment Option (the 'Investment Option')

On 8 December 2022, ASIC has revoked the Interim Order made on 24 November 2022 (Order) in relation to the Target Market Determination (TMD) for the underlying fund for the Investment Option (Revocation).

In light of the Revocation, we have:

- withdrawn the Supplementary Product Disclosure Statement dated 29 November 2022 notifying of the Order,
- withdrawn the Supplementary Additional Information for the Perpetual WealthFocus Investment Book dated 29 November 2022 notifying of the Order,
- issued an updated TMD for the Perpetual WealthFocus Super Plan, and
- issued a Supplementary Product Disclosure Statement dated 15 December 2022.

Accordingly, on and from 15 December 2022:

- the offer for the Investment Option under the Perpetual WealthFocus Super Plan Product Disclosure Statement issue number 14, dated 1 October 2022 (PDS) has recommenced; and
- we will resume accepting applications for the Investment Option and issuing units in the Investment Options in accordance with the terms of the PDS, as updated by the Supplementary Product Disclosure Statement dated 15 December 2022.
