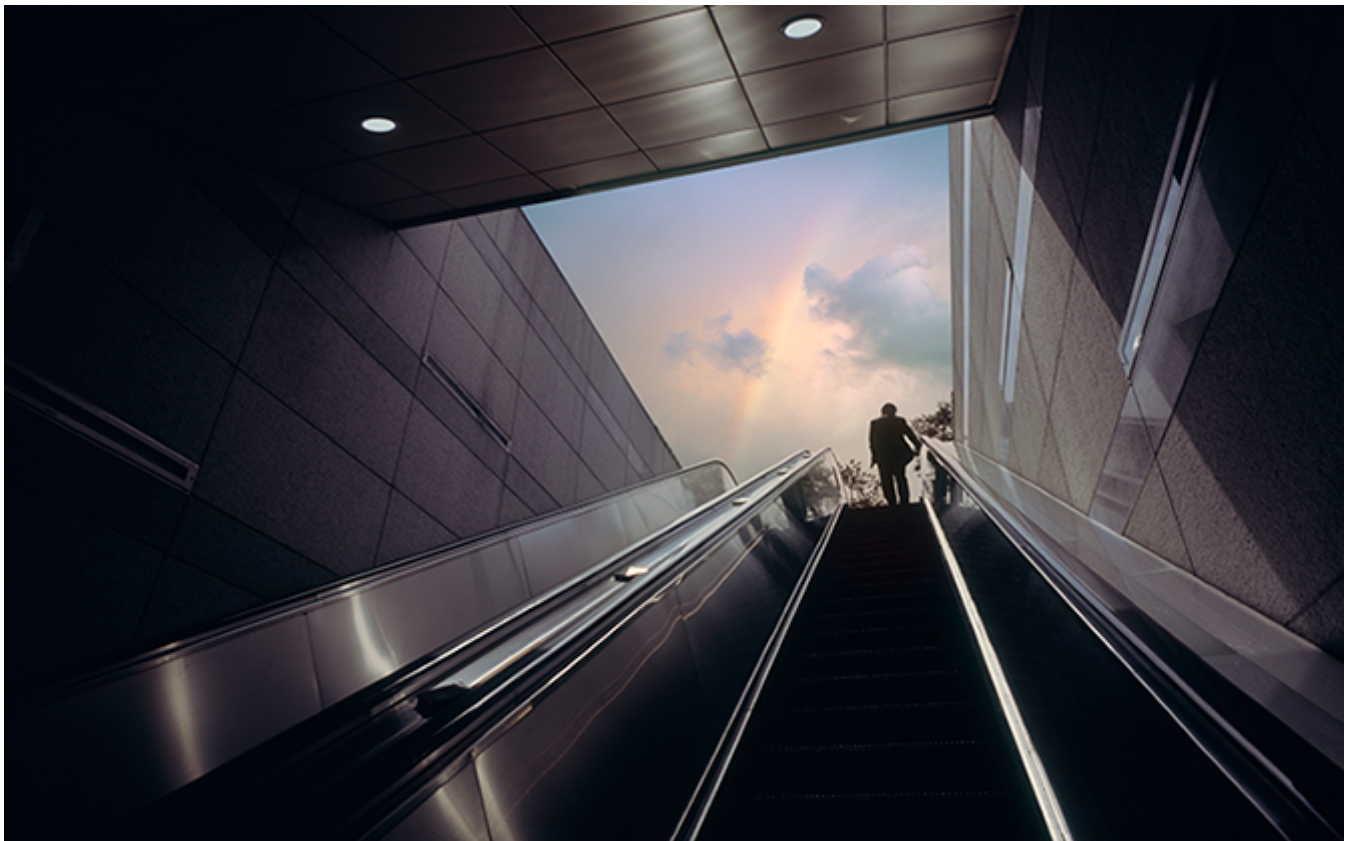


# Vince Pezzullo appointed Head of Equities; Anthony Aboud appointed Deputy Head of Equities
